Overdose Deaths in Geauga County

Decline by 45% in 2024

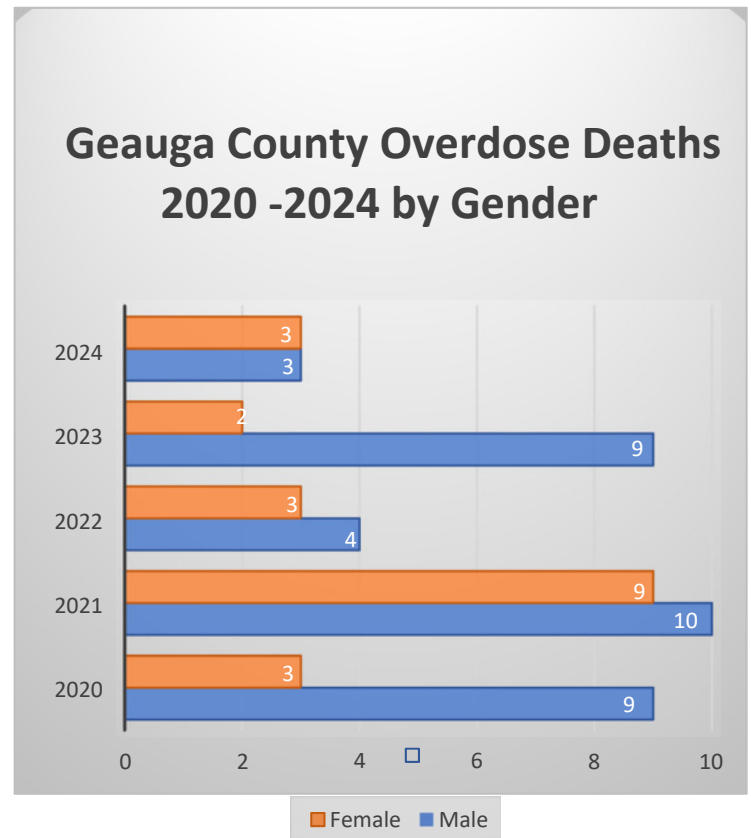
Reducing overdose deaths is a critical public health priority that requires a multifaceted approach to address this complex issue. In Geauga, overdose deaths were reduced from 11 in 2023 to just 6 in 2024. Here is a breakdown of key strategies and highlights:

Targeted Prevention:

This involves focusing on preventing substance use early with effective community based education.

Treatment & Recovery: Ensuring readily available and affordable evidence-based treatment for substance use disorders, including medication-assisted treatment (MAT), providing a comprehensive recovery support system, and addressing co-occurring disorders is crucial to healthy communities.

Collaboration & Partnerships: Fostering collaboration between law enforcement, behavioral health, the criminal justice system, and healthcare ensures access to appropriate and timely interventions that save lives.



Milestones in FY2024



May 2 & 3, 2024 - Sequential Mapping Workshop

Over 20 agencies came together to support the Stepping Up Initiative. A 5-point Intercept Map was created to identify critical points in the criminal justice system where those with mental illness and substance use challenges can be helped with access to treatment.



On November 7, 2023

Geauga County voters overwhelmingly approved our 0.7 mill renewal levy by 69%, which is the highest approval rate since 1989.

The Transitional Living Center Expansion Project

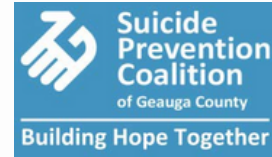
In partnership with Ohio Department of Mental Health & Addiction Services and the American Rescue Plan Act, the GCBMHRs is expanding the Transitional Living Center. The project will reach completion by the end of 2025.



The project will increase the number of beds from 9 to 16 so those experiencing crisis can remain in their community while they get the help they need. This expansion will also provide a kitchen that is better equipped to support improved life skills training, a new group/multipurpose room, and a private, dedicated room that can be used for art therapy, music therapy, or general interpersonal group therapy. Other new spaces to be provided include: new family visitation room, new staff respite room, new quiet/sensory room, basement storage for both resident possessions and bulk foods, and lastly, a new exterior covered deck area for resident use.



A Rebrand for the Suicide Prevention Coalition



Gauga is unique in that there is a mix of both suburban and rural areas with a population of about 95,500 people. We are the second highest in median income as a county, yet large disparities exist that limit access to the care for those who need it most. Our community averages one or more suicides per month. Currently, our high-risk group is men aged 50-75, but our outreach efforts center around the safety and support of all of our residents. We provide community education and advocacy as we strive to promote all of the wonderful resources Geauga has to offer!



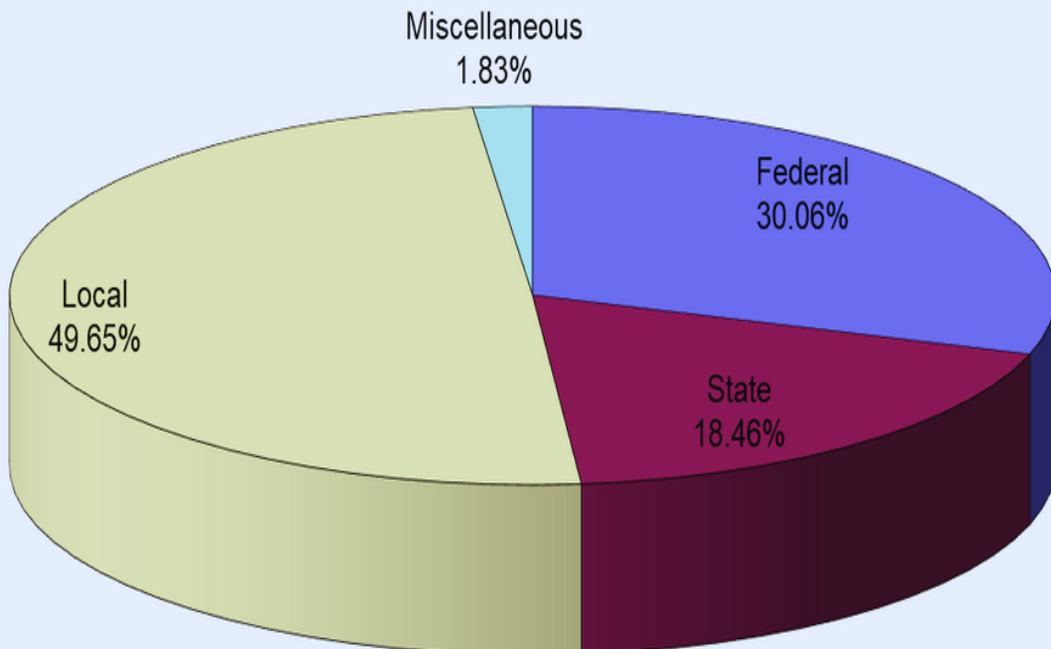
Mission Statement:

SFY2024 REVENUE SOURCES

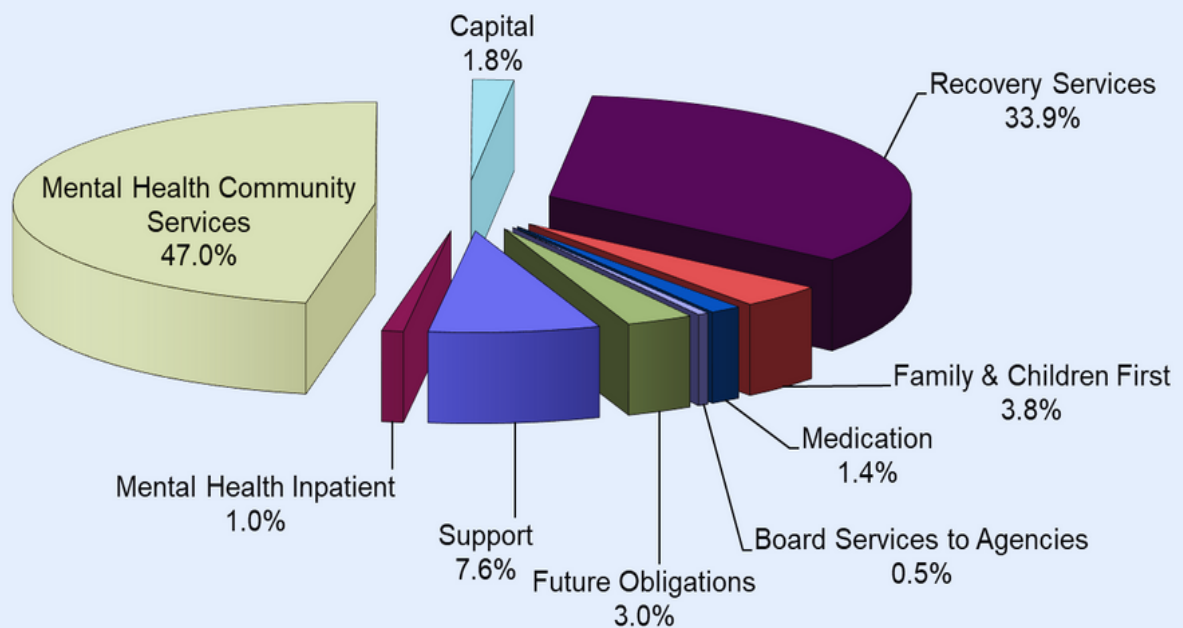
